- invest in a future where people with a learning disability are valued and treated as equals












Janet

Clothes define our personality and identity and without these small every day choices, the power that individuals have over how they live is gradually eroded.




These days, Janet loves to go clothes shopping with her support worker, stopping for a cup of tea or lunch afterwards.
